However, the computers for administration have been quoted higher than expected and we will not be able to purchase computers and chairs not to exceed \$5,000. Mrs. Taylor presented three quotes to the council and recommended they approve the bid from Absolute Consulting with a three-year warranty and bigger monitors.

Brent Christoher: Mr. Christopher also informed the council that he received a quote for a used computer and a hard drive to back up body cam footage. Mr. Christopher informed the council that he would rather go with Mrs. Sherry's quote for a new computer and add the hard drive to it.

It would take around 3 months to finish this process to get started. Stanley Freeland made a motion to approve the variance for Buchanan Drugs. Angie Hood seconds the vote. Motion carried 4-0. The city attorney will write up a resolution for this variance.

Mayor Scott: Mr. Scott and the council presented Stanley Freeland with a plaque recognizing his time served with the City of Buchanan as a Council member and Mayor Pro-Tem.

Mayor Scott: Mr. Scott asked for a motion to adjourn the meeting. Stanley Freeland made a motion to adjourn the meeting. Angie Hood seconds the vote. Motion carried 3-0.
